Vogel's PLA 9302:

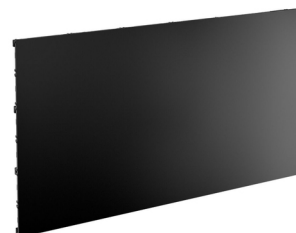
El soporte a pared ajustable 3D posibilita una alineación perfecta de la barra de interfaz dvLED (PLB 31xx) en la que se instalan los paneles dvLED.

De esta manera, es posible nivelar cualquier irregularidad de la pared, lo que facilita la instalación perfecta de un "dvLED wall". La profundidad ajustable del soporte a pared es de nada menos que 40 mm. PLA 9302 dispone de un ajuste de altura de precisión que permite la alineación horizontal de cada barra de interfaz dvLED tras la instalación. Este ajuste de precisión alcanza un total de 10 mm.

Los soportes a pared ajustables se utilizan en combinación con barras de interfaz, en 4 tamaños diferentes: PLB 3111, PLB 3120, PLB 3127 y PLB 3133.

Este producto no puede faltar en instalaciones en las que la pared no es completamente recta o si el videowall dvLED debe empotrarse en un espacio reducido.
